ADDENDUM A: BACKGROUND INFORMATION TO INFORM PLAN

Strengths

16-point increase from the previous year in ELA PVAAS

13% increase in regular attendance from 20-21

The initial year of MAP testing saw consistent growth across all grade levels that took the test in Fall 2022 compared to Winter 2023.

Students are beginning to connect the in-class lessons with the Mathia lessons online.

Mathia intervention is implemented with fidelity for all Algebra I students.

Teachers who regularly engaged and assigned students in Reading Plus showed an increase in growth.

ELA instructional coach started in January 2023 supporting all ELA teachers and groups of students identified for tier 2 support.

68% of students completed the ELA MAP assessment.

Math team has noticed a direct correlation between the number of minutes spent on Mathia intervention and MAP growth rate.

Challenges

The percentage of students scoring proficient or advanced on the Pennsylvania State Assessments English Language Arts/Literature decreased from 15.6% to 4.0% in 21-22.

The percentage of students scoring proficient or advanced on the Pennsylvania State Assessments Mathematics/Algebra had a minimal increase from 1.4% to 2.0% in 21-22.

The percentage of students regularly attending increased from 10% to 23.1% in 20-21.

ELA teachers did not consistently engage and assign students to Reading Plus.

ELA instructional coach was an internal hire leaving a vacancy in the ELA department.

Students are not completing Mathia workspaces with fidelity. Students are not completing assigned Mathia workspaces for homework.

Students are not completing Reading Plus workspaces with fidelity.

Strengths

All 3 essential practices under the component Foster Quality Professional Learning increased from Not Yet Evident to Emerging status. Through CSI/DCIU partnership with CHS, specific subgroups of the school educator community have received professional learning specific to their content and instructional needs.

Essential Practice #3 went from Not Yet Evident to Operational status due to adopting and effectively administering MAP assessments.

Essential Practice #7 went from Not Yet Evident to Operational status due to having an instructional coach for 1/2 of the school year to support and shape teaching and learning at CHS.

Biology instructors provided curriculum resources to students that are aligned with the Keystone Assessments.

A College and Career counselor was hired to support and promote college and career initiatives.

Preparation and review materials provided to students, as well as supplemental online resources for the Civics exam

Exposure to college campuses and college academics enhanced student interest to attend college. We provided college tours and career events to encourage student participation and attendance.

Challenges

Average proficiency on MAP ELA assessment is: 9th 2.7% proficient 10th 3.0% proficient 11th 3.4% proficient 12th 4.4% proficient

Essential Practice #6: If all students, educators, families, and community members foster a culture of high expectations for success then school climate and student achievement will increase.

Essential Practice #11: If CHS promotes and sustains a positive school environment where all members feel welcomed, supported, and safe in school: socially, emotionally, intellectually, and physically then students will be ready to receive teaching and achieve more academically.

Staffing in the math department has been a challenge this year. The team has two positions open. This is creating larger math classes and shifts in teachers during the school year.

There was a decrease of 11.5% in the Career Standards Benchmark from 20-21.

There was a decrease in the 4-Year Cohort Graduation rate from 61% to 46%.

No uniform standards-based assessments for Biology. There were (3) Biology teacher resignations during the school year.

Strengths

We will provide academic materials and resources in their native language.

We have established Parent-Teacher committee to increase cultural awareness and community involvement.

Challenges

Eligible students to attend and participate in the college and career events.

Lack of Parent involvement and support for processing student's FAFSA.

Students' hesitancy to apply for scholarships and funding, due to apprehension of change and relocation.

ELL/ELD Parents and Guardians have limited or no English-speaking abilities.

Lack of Parent involvement due to non-citizenship.
