The Receiver's meeting opened with a call to order by Receiver, Dr. Juan Baughn and the Pledge of Allegiance.

#### REPORT FROM THE SUPERINTENDENT

Good evening Dr. Baughn, good evening board members, our families, our students, my team and, of course, the public. I am so excited to welcome you to the receivers meeting this evening. We're excited to welcome you to our receivers meeting this evening. Before I begin my formal presentation, I'm going to begin with this part of the evening that I so enjoy very much. And it makes me always remember my why. We have a presentation from Dr. Green and our sensational, lovely, talented and gifted jewels from Stetser Elementary School. Dr. Green?

So thank you very much for letting us share and letting us recognize women's history. Also, this month, just to give a few highlights as it relates to learning and teaching in the district. During the week of March 8th, we provided resources to our pre-K students and their families to help enrich their educational experiences, so I want us to thank our curriculum team. Dr. Pearson and Ms. Mclaughlin and others.

We also, during this month, we're planning our academic night, which will take place on April 28th. So please mark your calendars. We will have an academic night, so we're inviting everyone and we're giving you ample notice so that you can attend our academic night. We had a very successful academic night back in the fall. Visually, we are really excited to acknowledge members of our learning community who have been identified as being the light.

We have an employee as well as the student recognition ceremony entitled, "You are the light." And so, I'm going to announce those recipients for the month of March. We have our community hero, Ms. Katherine Kiefer, who is a teacher at Toby Farms. Let's give it up for Ms. Kiefer. Yes. Our trendsetter is Ms. Macheda Ishmael. She is a truancy officer at Chester High School. Our classroom catalyst is Mr. Pasque Scorezeti. He is a teacher at STEM.

Now, let's acknowledge our precious jewels, our students, our community hero, Ms. Mariama Kabba. She's a student at STEM. Our trendsetter is Ms. Aria Sullivan, Main Street. Our classroom catalyst is Christie Bassana. Let's give it up to our You-Are-The-Light award winners for the month of March.

As it relates to family and community engagement, we are going to have Coffee and Conversation with yours truly, Dr. Carol D. Birks and with the distinguished women from Chester. There is a flyer that we sent out throughout our learning community. You can also find all the information on Facebook and Instagram and all our social media outlets. And we are showcasing some exceptional women who have walked the same hallways of Main Street and STEM and Chester High School.

Maybe some of them go to STEM. I think it was called STEM at Showalter back then, but most that walked the halls of Chester and they are extremely successful. So we are very, very excited. We also have someone, one of our teachers that we are acknowledging this evening with a special recognition and Dr. Chambers is going to help me acknowledge that particular teacher this month.

**Dr. Lakiyah Chambers -** Yes, we would like to acknowledge from Chester High School, a teacher in the civics and government department as our special educator for the month of March, you are the light, Ms. Kim Mosquito. Thank you so much, Ms. Mosquito for being a mentor to so many of our teachers and for your love and commitment of our students. Congratulations!

### Clapping and cheering

Thank you. Oh, and I want to go back to our family and community engagement, March 23rd. Mark your calendars, March 23rd at 06:00 PM, these sensational women will join us and Dr. Chambers is going to tell us a little bit about the women that we are going to have coffee and conversation with.

**Dr. Chambers** - Yes, absolutely. We are hoping that you join us on March 23rd. We will be conversing with superintendent Birks and some esteemed and distinguished women within the city of Chester who have shattered the glass ceiling. Those who will join us for this conversation, we'll have a greeting from Councilwoman Elizabeth Williams from the city of Chester and our panelists include Dr. Jackie B. Ervin, vice provost for student development at Eastern University. Ms. Monica J. Washington Esquire, director of labor relations for Temple University. Ms. Kenya de Lindsey, nurse practitioner, internal medicine, Penn medicine, and Ms. Adrian Irving, director of legislative and community services, Delaware County, intermediate unit. We will be hosted by none other than our superintendent, Dr. Carol Birks, and I will be moderating. So we are excited. Again, this is next Tuesday, March 23rd, 6:00 PM. So share the news and the word. And we're looking forward to bringing these Chester Upland School District alum together to have some great conversation. Thank you.

Thank you, Dr. Chambers. And then some people, "So I don't drink coffee." Well, bring your tea, bring your water and come chat with us and learn a little bit about the women who have ... what's that saying Dr. Chambers, that you keep telling me about?

Dr. Chambers - What Chester makes, makes Chester.

That's right. What Chester makes, makes Chester. So next week, please join us. As well as we have a competition happening currently, and we're going to honor distinguished women. So on our website and on Facebook, there is a nomination form that you can nominate a distinguished woman who's made contributions to our community. And so, it could be a young woman, it could be a middle-aged woman, it could be a seasoned woman. It could be any woman, but in honor of women's history month, we want to acknowledge women within our community. So please go and nominate individuals. Now, back to what I was saying, we're going to call on our precious jewels from Stetser. Dr. Green, we're excited about hearing the presentation this evening. I think our it team is ready to assist.

The students gave a presentation for women's history month. They told stories of prominent African American women throughout history who overcame the odds to become successful business women, doctors, lawyers, scientists, etc.

That's our elementary school. Yes. I want to thank you, Dr. Greene. To all of our faculty and staff at Stetser. Of course, to our sensational, beautiful, lovely, creative and talented children at Stetser Elementary School. Yes. And I want to also thank your families, to all the parents of our Stetser children we want to say thank you. Let's give it up for the parents.

We want to thank you for allowing us to educate your children and to love them and we are so moved. That was so inspiring. I'm so proud to be a woman. That was so inspiring with a job well done. Our students are extremely creative and talented and I'm so happy that we have this opportunity to display their gifts to everyone. And so, let's give it up for Dr. Green again.

So I have two more quick announcements I want to bring to everyone's attention and then I'm going to turn it back over to Dr. Bonn. I just want to remind all of our families and I would be remiss as superintendent if I don't say this, we are encouraging you to send your precious jewels to school every day. We have two cohorts: cohort C and U. Cohort C meets on Mondays and Tuesdays and cohort U meets on Thursdays and Fridays.

On Wednesdays, we teach our children in the morning. Our teachers are at home virtually, and then they engage in professional learning. And we focus on how to teach in this environment as well as providing social, emotional learning support. So you're like, "What are they doing on Wednesdays?" Our teachers and our staff, not just teachers, I want to commend our security staff and climate managers and others, a police officer, everyone is learning on Wednesday, administration and everyone. And so, that's what happens on Wednesdays.

So we need more of us engaging in coming to school because we know our kids have the talent and gifts and we're in the ... And I love saying this and everyone looks at me because we're in the learning business. And so, and in the learning business, we want everyone learning. So I'm excited and I have one more announcement.

We want to thank everyone. All of our faculty staff, including our students and our services team in helping to ensure that we have our mitigation strategies in place to help keep us all safe from the effects of COVID-19. So we have testing within our schools that we just launched a new testing program within our schools, as well as many of our faculty and staff members have been vaccinated.

And so, parents please send your kids to school. We have you look at our video that's on Facebook. We've put in all the recommended precautions in place that have been recommended by the center for disease control and prevention, so that we can have you come and learn in person. There are so many significant benefits from learning or in-person learning: there are academic benefits, their social benefits and social emotional benefits from learning in person. But we need more of you to send your children to school every day.

So I want to thank you. And I'm going to turn it back over to Dr. Baughn. Thank you, Dr. Baughn. That concludes my superintendent's report.

**Dr. Baughn -** Thank you, Dr. Birks. Thank you, Dr. Greene. Thank you to the Stetser family and to your wonderful youngsters. Thank you. Thank you. Is Dr. Nunnery on the line? Okay. I'm moving on with the agenda.

### APPROVAL OF MINUTES OF PREVIOUS MEETINGS OF FEBRUARY 28, 2021

Receiver Dr. Baughn approved.

#### **PUBLIC COMMENTS**

**Dr. Juan Baughn -** I'd like open it up for ... Oh, in the chat room, there was a question about attorneys and attorney fees. I'm working with the business office to put together the cost of our attorneys and comparisons, so I will have that in the near future. I'm opening the floor now for public comments as it relates to the agenda this evening. When you comment, please give your name and address for the record. Thank you.

#### Via Q&A:

**Jean Arnold -** As it pertains to the agenda, Dr. Baughn, please share why we have not engaged ... you have not engaged the community more in the RFP process as the judge requested. Please publish the complete proposal for all bidders to date. Also publish the detailed decision criteria the taskforce will be using to evaluate the proposals.

**Dr. Juan Baughn -** Okay. Dr. Nunery, you heard the question. Let's see if you can answer that question as you give us an update as relates to the RFP process.

**Dr. Leroy Nunery -** Certainly. Good evening. I'll just give the report I was going to give Dr. Baughn as you'd requested, and I think it will address the question that was just posed. The RFPs that we received as of the end of February were three, from Global Leadership Academy, Friendship Education Foundation and Chester Community Charter. We had eight organizations that we expected to hear from. They had also submitted formal responses to the request for interest, but only three in organizations filed responses to the RFP, which is essentially the engagement step that we're talking about right now. So we have three proposals and all of this was put in a report sent to Dr. Baughn and should have been posted on the website.

The taskforce of Fred Green, Jackie Irving, Anthony Johnson, Latoya Jones, LaMonte Popley, Tyra Quail, William Riley and Kenneth Washington have been communicated with on a regular basis, keeping them updated on where we were with the entire process. As you know, from the last time I believe I reported in, we had some delays due to court motions, but all of that has been resolved after January 11th and we're on our way. Assisting the task force is myself as a strategic advisor, two of my associates, Jeff Cardwell and John Polk. And then also, Jack Pund and Mari Grochowski who you know also work with the district as strategic advisors, so we are staff to that task force. The task force had an orientation meeting back in February and then met officially in March after we finally got the proposals in hand on March 10th.

On March 10th, we had a Zoom meeting with several members of the task force, not everyone attended, but we did have more than a quorum. And we went through each of the proposals on our step-by-step proposal-by-proposal basis to find out what was positive and what was not positive about each proposal. And also, ask a series of questions that the task force had about each and every proposal.

All of that has been recorded and that has gone to the RFP taskforce for their notes. Each of the proposing organizations will be contacted tomorrow with some directions for a presentation, initially to the RFP taskforce. Those proposals, I know that there were some motions, I won't get into the legalities, but as we outlined in the process from the very beginning and that the judge of from the Delaware Court of Common Pleas has approved, we're going to have the task force do the first initial read and rating of the proposals.

After presentation scheduled in early April, the task force will make a recommendation to the receiver, an initial recommendation. We may not have any recommendations to make. There may be all three, it may be two, it may be one, it may be none. But no matter what, the task force job is to do a debrief, an intensive review, submit an initial recommendation to Dr. Baughn.

Once he determines, and that's also written in not only the court orders from May 14, 2020, but the revised court orders on January 14, 2020 that we can go forward, we will then have public presentations of one, two, three, or none, or all of those proposals. And that's when the public will have an opportunity as written in the RFP. And the whole process has been outlined therein. That's when they probably will have a chance to hear out each of these organizations. We have further due diligence to do. Now, COVID has made it impossible to just travel wherever we would like to. But if possible, I'd like to get the task force members to tour at least one of those schools and each of the proposers. Final recommendations, along with all this information, including public feedback, we'd go to Dr Baughn probably sometime in early May at the earliest.

And if he, with these recommendations and the court and PDE and all other stakeholders determine that we can go forward, then we would go into contract negotiations and so on with each or any of the organizations that have stepped forward. The criteria was mentioned in the question. Those criteria folks are in the RFP documents, spelled out weighted criteria for each area that we'll be reviewing, including academic program, curriculum and instruction, parental engagement, community engagement.

We're going to add a piece to it on school safety. Not talking about physical safety in terms of facilities, but if in fact students are able to return to school in-person, we need to understand what their health and safety precautions will be. There are criteria around special education. Of course, there's an important criterion around the Financial Recovery Act in terms of whether or not any of the proposers can, in fact, say that there are going to be economic savings to the district.

So folks, I urge you...I understand that the keen interest in seeing everything, but the process that we outlined is the one that we are following. And the one that the judge approved, number one. Number two, because we're trying to do it this way so that we protect not only the integrity of the proposals, but also make sure that when, if any proposer comes forward, they have been vetted in a serious way.

And so, that's the status that we've got. This has been a lot of time, a lot of work just to get it to this stage. I have no idea how it's going to come out. I don't think Dr. Baughn has any idea yet how it's going to come out, but we'll do it in the sunshine and we'll make sure that whatever's presented is right based on what we outlined his criteria and evaluation waiting and so on. So, Dr. Baughn, I'll pause there to see if anybody has any questions.

Ms. Arnold - Please allow the public to observe the training provided for the task force to do their job.

**Dr. Nunery -** I'm not even sure how to respond to that.

Dr. Baughn - We'll take that under advisement.

**Dr. Nunery -** Right. There may be something ... Dr. Baughn, I can offer this. We did record the orientation meeting I did back in February. We can provide that, but I'll leave that up to you, sir.

**Dr. Baughn** – We'll take a look.

Carol (No last name) - Can Friendship Education Proposal be extremely examined? They do not have the best track record.

**Dr. Baughn** – All of the proposals will be extremely examined.

Dr. Nunery - Correct!

**Dr. Baughn** – There being no further questions, I will move on with the Agenda. If you have questions that aren't pertaining to the Agenda, please put them in the Chat Room and we will take a look at them and get back to you. Thank you.

## C-11 Approval to adopt the Accelerated Budget Opt Out Certifying Tax Rate Within Inflation Index

The purpose of this resolution is to allow the school district to follow normal budget procedures, and dispense with the more complicated, expensive, and accelerated Act 1 budget requirements. This option is available only to school districts that are certain the next year budget can be funded without increasing the real estate tax rate by more than the index (and therefore without seeking approval for any index limit exceptions). This resolution may be adopted after the preliminary budget is available, or the board has sufficient information to be certain the budget can be funded by a tax increase within the index. For fiscal year 2021-22, the resolution must be adopted no later than March 30, 2021.

**Background.** Act 1 § 311(a), 53 P.S. § 6926.311(a), requires an accelerated budget adoption timeline and procedure unless a school district, no later than 110 days before the primary election, adopts a resolution containing the certifications incorporated in this resolution. After adoption of a resolution containing such certifications, § 311(d) authorizes a school district to comply with pre-Act 1 budget adoption rules as set forth in School Code § 687, 24 P.S. § 6-687. The School Board has reviewed the school district preliminary budget or has other information sufficient to make a determination that the budget for the next fiscal year can be funded based on maintaining current tax rates or increasing taxes by an amount less than or equal to the Act 1 index. In lieu of the Act 1 budget adoption timeline and procedure, the School Board wishes to make the required certifications and comply with pre-Act 1 budget adoption rules.

RESOLVED, that the Board of School Directors of the Chester Upland School District, makes the following unconditional certifications:

- 1. The school district's various tax levies and other revenue sources will be sufficient to balance the school district final budget for the next fiscal year (2021-22) based on maintaining current tax rates or increasing tax rates by an amount less than or equal to the Act 1 index applicable to the school district as calculated by the Pennsylvania Department of Education. This conclusion is based on the school district preliminary budget or other information available to the School Board.
- 2. The applicable index for the next fiscal year is 4.9% and the School Board will not for the next fiscal year increase the rate of its real estate tax, or any other tax for the support of public education, by an amount that exceeds the applicable index.
- 3. The School Board has to date and in the future will comply with the rules set forth in School Code § 687 for adoption of the school district proposed and final budgets for the next fiscal year.
- 4. The School Board understands that the school district will not be eligible to use Act 1 referendum exceptions for the next fiscal year.
