A Public Meeting of the Receiver of the Chester Upland School District was held this evening at the Administration Offices, 232 West 9th Street, 1st Floor, Chester, Pennsylvania.

The Receiver's meeting opened with a call to order by Receiver, Mr. Peter Barsz and the Pledge of Allegiance.

REPORT FROM THE SUPERINTENDENT

The Superintendent introduced Dr. Eric Pugh, Supervisor of Pupil Services. Dr. Pugh gave a report on a pilot program for the Early Warning Intervention System.

Dr. Pugh - The reason that I'm here tonight is I want to share a pilot program that we're instituting here in the Chester Upland School District called Early Warning Intervention System. Just to give you a little background about what this system is, it's a pilot study that we're going to be doing with both Chester High School and STEM where we want to focus on early warning systems. We're going to focus on three domains. We're going to focus on attendance, academic performance, and behavior. And we're going to flag students who are struggling in those areas and create intervention models to support the students and that model. So, we were given a \$10,000 grant through the PaTTAN and the DCIU to be able to create research-based interventions to support students who are struggling with attendance, behavior, and academic performance. They're also going to be supporting our ninth grade teachers with providing support to creating interventions that's going to best serve our students. And the purpose of this grant is to focus on decreasing ninth grade grades where students are struggling. And research states that students who struggle in ninth grade often drop out of high school. So, we're really want to focus on the ninth grade academics so that we are setting up our students for success. Hopefully, if the grant is successful, our goal is to really trickle down to the middle school level so that we can target students early so that when they come to ninth grade we have an intervention plan in place for them to be successful. Thank you.

Anthony Johnson - I got a question. Is truancy going to be involved?

Dr. Pugh - Yes.

Mr. Johnson - Okay.

Dr. Pugh – Yes. We're going to be creating a team that's going to consist of not just the ninth grade teachers, but also the guidance counselors, the social workers as well as other support staff that will best serve the students to address those domains.

Mr. Johnson - Okay.

APPROVAL OF MINUTES OF PREVIOUS MEETINGS OF SEPTEMBER 26, 2019

Receiver Barsz approved.

PUBLIC COMMENTS

Anita Flood-Miller - Good evening. I'm here in reference to [student] my nephew who's attending Stetser Elementary School. I was here at the last meeting, and my concern with [him] is that he doesn't have a permanent teacher. Still, it is a little better because they have a teacher there that's been there for three weeks. She's not the permanent teacher that's supposed to be representing this class until ... I don't know whether the ... I forgot her name ... his normal teacher that was supposed to be there that's sick, that's out sick. Oh yeah, Ms. Mahoney. Okay. So, since then, I expressed that [student] is going for tutoring because [student] has been flip-flopped between kindergarten, first grade classes, second grade, first grade classes. He's not getting what he needs, and I'm paying for him to get tutoring twice a week. Tutoring twice a week is not enough for [student] to get what he needs. I don't know how long it's going to take for them to get a permanent teacher in there, but at this time, [student] is ... this classroom is failing. I'm concerned about [student] failing. [Student] is on a first grade level in the third grade. I had an email sent to Mr. Pugh and to Miss ... I don't remember ... I don't know the lady name because she wasn't here the last time. And the other person's name was ... I had all this in my head, I can't remember.

Mr. Johnson - MacDougal?

Dr. Pugh – Nikki Monroe-Hines?

Ms. Miller – No, no. The principal, Ms. Baldwin. So, Miss Baldwin was supposed to call me the next day. She did call me five days later and gave me some great news on October 6th that there was going to be a teacher starting that Monday. Today is the 17th there is not a new teacher, a permanent teacher still in this classroom.

My concern is is that [student] is in the third grade, he's on a first grade level, he has an IEP, and at this point, him getting put into another classroom, which they have recommended that he be transferred into another classroom. My problem with him being transferred into another classroom is that if this classroom has been with this permanent teacher on the beginning of the year up until now, October 17th, where are they? And if he's going into another classroom, is someone going to be there to help him to get where these other kids are? Because now these kids are up here, he's still here, so where is that going to leave [student]? Is this going to help him, or is this going to be good for him, or is this still not going to be good for him is my concern.

I need [student] to get what he needs. I moved him from one school to here thinking it was going to be better, and I really don't think it's been since the beginning of the school year. I can't afford to keep sending him to tutoring to get him on the basics that he needs to get, where to get him up ... trying to get him up. Because two days a week in seven days out of the week, he's going to lose what he had for two days.

Dr. Dr. Baughn - If at the end of the meeting, if you can ... You and I can get together for a few minutes, and I'll look into this. I'll look into this myself.

Mr. Johnson - Last month we were supposed to replace, like she said ... Anita said, replace the teacher. So, whoever is her child's case manager, the kid ... what she's saying is they're pulling him because he's in these restricted environments. So, he's getting pulled out by his case manager. But she's saying they're grouping him kindergarten, first, second, and third grade. Are we short case managers too, or special ed teachers too? Because Mahoney ... I think that's who's out sick, is the regular ed teacher. So, that's the biggest concern. And if I'm getting it right from the parent, is when the child is getting pulled out. I might be off, if I'm hearing ... Because I think I talked to you and Miss Beaver last month and I tried to get into my head what was going on, but they said to you that it was going to get taken care of.

Ms. Miller – Exactly.

Mr. Johnson - So ... And that's not a hard fix either. We short in the classroom because the teacher's ill, we can't help that. And then, we knew she might be out for length of time, so I thought I heard we were going to hire somebody to replace her.

Dr. Baughn - And that's what I thought I heard too.

Tyra Quail - That's what they said in the last meeting that they had hired somebody.

Ms. Miller – Right. So, and I also need to understand this. Special ed teacher, the case manager, the social worker, is this all one person, or is this three people?

Mr. Johnson - It's two.

Ms. Miller – Okay.

Mr. Johnson - We call ... They changed the terminology ... We call the special ed teacher a case manager because they have what they call a case load. Which is when they pull the child out of the regular ed classroom, and they help them with their lessons so they can stay in compliance or stay up with the ... He's in third grade, right?

Ms. Miller – 45 minutes, yes.

Mr. Johnson - Right. Right. And that's part of the iIEP ... We're honoring the IEP.

Ms. Miller – Yeah, and that has started.

Mr. Johnson - Okay.

Ms. Miller – Now, I went to the school because I went to take a letter. I went to talk to the social worker because I wanted him to get his IEP done over and get his ... I'm sorry. I had a head injury, so I just -

Mr. Johnson - Take your time.

Ms. Miller – Yes. So ... him to get ... what is it called?

Dr. Pugh - Therapy.

Ms. Miller – Therapy. Well, he's going to therapy. And now, I'm taking him to therapy also. He's going to therapy, so he started therapy.

Mr. Johnson - Like Dr. Baughn said, definitely get with him after the meeting because a lot of this stuff, I don't want ... you know, it's personal, and a HIPAA issue. I don't want everybody to know your business, so can you-

Ms. Miller - Right, okay, so-

Mr. Johnson - Definitely get with him after the meeting.

Ms. Miller - Okay. Well, the social worker ... when I called out for the social worker when I went to school ... because I'm not a phone person, I'm coming to you because I want to see you eye-to-eye. So, when the social worker came out, she told me she was not the social worker, that his case manager was his social worker, and she was also his special ed teacher that brings him out of the classroom for 45 minutes. So, I'm confused.

Dr. Baughn - Let me see if I can help you clear up some of that. The other thing I wanted you to know is that we've hired a permanent teacher, and that teacher is scheduled to start on October 28th. But let's talk more at the end.

Ms. Miller - Okay.

Dr. Baughn - And so I can understand more, okay?

Ms. Miller - Evaluation is the word I couldn't think of.

Dr. Baughn - Okay.

Ms. Miller - Yeah, they tell me he needed to be evaluated again. Thank you.

John Shelton, Jr. - Good evening, School Board. Good evening, Receiver and the board who are handling, running our ship. Our ship is in dire straits and dire needs of certain things [inaudible 00:12:38] to be beneficial for our students. I believe we're all on the same accord to know what those needs are. I'm not going to repeat those needs because that's an in-house conversation that needs to be handled by administration along with the administrators of each one of the buildings in your care. I am going to say that the teachers are here to follow your leadership to make sure our students get what we need when they need it. We've been working hand in hand with you, and we continue, and are going to continue to work with you. When you feel it necessary to change or add to what needs to be done, our teachers are there, and we've always been there. I ask for the administration to give serious consideration to make and rest at ease our minds of our teachers. In doing so, at this point, we are in complete confidence that what you're doing so far is where it needs to be. I've had a conversation with Mr. Johnson, I've had a conversation with Dr. Baughn, and I think we are where we need to be and hopefully continue to work together and make everything work the way it needs to work. I want to thank all the people who came out this evening for the interest of our children.

We've got a struggle, and this is the part that's most important for us right now. We have a struggle to make sure our children live long enough to get an education. Our city's in dire straits. You know, if you live here. Most people who are here tonight live here and know what kind of problems that we have with our children. We need to work this out. Those students who cannot conform and participate in our buildings where they need to, we need to turn up the care for them. We don't want the children who are here for 100% of the time suffering behind any children who are not here for the same reason. And that's all I have to say this evening.
