C-10 Approval to finalize tax appeals between CUSD and DN Acquisition Company

RESOLVED, that the Receiver, acting as the Board of School Directors authorizes the Solicitor to finalize resolution between Chester Upland School District and DN Acquisition Company, LLC, of the four tax exemption appeals in Delaware Court of Common Pleas, Docket Nos. 2017-9857, 2017-9848, 2018-1295 and 2018-1293 as follows: for the City’s triennial tax year 2018-2020, an assessment of \$100,000 and a fair market value of \$400,000 and the Property Owner will forthwith withdraw its *nunc pro tunc* appeals for the 2015-2017 tax years currently pending before the City Board.
